TERMS OF REFERENCE

PROJECT NAME: Procurement of Comprehensive Motor Vehicle Insurance for the

Official Vehicle of the Permanent Mission of the Philippines to ASEAN in

Jakarta, Indonesia, a 2017 Mercedes Benz E300 Sedan.

APPROVED BUDGET FOR THE CONTRACT: IDR 10,000,000

BACKGROUND

The Permanent Mission of the Philippines to ASEAN in Jakarta, Indonesia intends to procure a comprehensive motor vehicle insurance for its official vehicle a 2017 Mercedes Benz E300 Sedan, for one year (20 September 2024 to 19 September 2025).

OBJECTIVE

The objective of this undertaking is to ensure that the official vehicle of the Mission has comprehensive or all-risk coverage insurance.

APPLICABLE RULES AND REGULATIONS

The selection of an insurance company for the project shall be done in accordance with the Government Procurement Policy Board (GPPB) Resolution 28-2017 dated 31 July 2017 (Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be Procured and Performed Overseas).

The Permanent Mission of the Philippines to ASEAN in Jakarta, Indonesia, by entering into a contract with the successful bidder, does not waive its sovereign immunity, as the project is being undertaken as an official act. In this regard, any conflict arising from the implementation of the project shall be resolved through negotiations.

SERVICES

The insurance coverage shall include the following:

- 1. Any damage/s or loss of the vehicle due to collision, theft or other traffic related accident;
- 2. Extended coverage for damage/s or loss incurred by the vehicle through riot, strike, civil commotion, terrorism or other man-made disasters:
- 3. Extended coverage for damage/s or loss incurred by the vehicle through all types of natural disasters;
- 4. Extended coverage for third party legal responsibility;
- 5. Extended coverage for the driver and a maximum of four (4) passengers should an accident arise; and
- 6. The comprehensive motor vehicle insurance shall begin on 20 September 2024 to 19 September 2025.
- 7. A good record in handling insurance claims.

PAYMENT SCHEME

Payment will be made within thirty (30) days from the date of receipt of the official invoice.
